- 2) The Tender shall be submitted along with EMD of Rs. 25,000/- (Rupees Twenty Five Thousands Only) in the form of the Demand Draft in favour of **“DBM Geotechnics & Constructions Pvt Ltd”** payable at **Mumbai**.
- 3) The tender shall be completed in all respect and should be signed with date by the Authorized Signatory of the tenderer on all the pages.
- 4) The offer price shall be quoted for the scrap on lumpsum basis on **“as is where is”** basis excluding government taxes and duties. The taxes & duties should be mentioned separately in the offer document.

 - c. The truck/tempo/crane/lifting appliances for Scrap lifting and transporting (for removal) shall be arranged by the successful tenderer at their cost. The successful tenderer shall have to make arrangement for loading of scrap to truck/ tempo at their cost and DBM Geotechnics & Constructions Private Limited shall not pay any charges for the same.
